1. Introduction and Aims

3. Assessment Framework at Rawdah Montessori

Rawdah Montessori provides a unique educational experience, blending the Montessori method with the National Curriculum of England, all underpinned by Islamic values. Our academic performance is therefore measured using a combination of approaches:

1. **Montessori Progress Tracking:** Teachers observe and track children's progress against the Montessori curriculum planes of development.
2. **National Curriculum Standards:** In Key Stage 1 and 2, pupils are assessed against the standardised expectations for their year group.
3. **Early Years Foundation Stage (EYFS):** In Nursery and Reception, performance is measured against the Early Learning Goals (ELGs).

4.1 Early Years Foundation Stage (EYFS)

- **Small Class Sizes:** Our Montessori approach benefits from low pupil-to-teacher ratios, allowing for highly personalised learning. This positively impacts academic outcomes but means that percentages can fluctuate with the movement of a small number of pupils.

- **Mixed-Age Classrooms:** In line with Montessori philosophy, children learn in mixed-age groups. This fosters peer-to-peer learning and leadership, which supports academic development.
- **Inclusion:** We are committed to inclusive education. The data above includes pupils with Special Educational Needs and Disabilities (SEND) and those with English as an Additional Language (EAL), who receive appropriate support to access the curriculum.
- **Faith-Based Values:** Our curriculum integrates Islamic character education, which supports pupils' focus, discipline, and sense of purpose, contributing to a positive learning environment.
